MORAYO AINA	OUR CLIENT GOT MARRIED TO HER HUSBAND ON THE 23 RD MARCH 2000 AT SOMOLU AND THE MARRIAGE PRODUCED FIVE CHILDREN. THE HUSBAND OF OUR CLIENT HAVING TAKEN OTHER WOMEN AS WIVES SENT OUR CLIENT OUT OF HER MATRIMONIAL HOME IN 2013. BEFORE SHE WAS THROWN OUT, SHE WAS GROSSLY ASSULTED AND ABUSED BOTH PHYSICALLY AND MENTALLY, TO THE EXTENT THAT SHE WAS HUSPITALISED ON SAVERAL OCCASSIONS.	WELA HAVING TRIED TO MEDIATE TO NO AVAIL, FILED A PETITION IN 2013 FOR AN ORDER FOR THE DISSOLUTION OF THE MARRIAGE, AN ORDER GRANTING THE CUSTODY OF THE FIVE CHILDREN TO OUR CLIENT, AN ORDER SHARING EQUALLY BETWEEN THE PARTIES ALL PROPERTIES ACQUIRED DURING THE MARRIAGE, AN ORDER FOR THE MAINTENANCE OF THE CHILDREN BY THE RESPONDENT ETC.	THE COURT ON THE 9 TH DAY OF APRIL 2018, GAVE JUDGEMENT ON THE MATTER IN FAVOUR OF OUR CLIENT THUS: THE MARRIAGE WAS DISSOLVED, CUSTODY OF THE FIVE CHILDREN AWARDED TO OUR CLIENT, THE MATRIMONIAL HOME WAS DECLARED A JOINT PROPERTY AND OUR CLIENT ENTITLED TO OCCUPY SAME, THE SUM OF N100,000 EACH AWARDED AGAINST THE WIVES FOR COMMITTING ADULTERY WITH THE RESPONDENT, N300,000 AS MONTHLY MAINTENANCE ALLOWANCE FOR THE PETITIONER.
